## **Indemnification Agreement**

Applicant (herein referred to as 'Contractor' or 'Subcontractor') shall indemnify and hold harmless the Village and Village's agents, servants, and employees against all loss, damage, taxes, liabilities, charges or expense, including but not limited to attorneys fees and court costs, which the Village may sustain or for which it may become liable on account of injury to or death of persons, or on account of damage to or destruction of property resulting solely from the performance of work under this Agreement by Contractor or its Subcontractors, due to or arising solely from the intentional or wrongful act or gross negligence of Contractor or its Subcontractors of any employee of any of them, or otherwise arising out of this Agreement or the Contractor's performance of services on behalf of the Village.

The Contractor shall be responsible for any and all damages to property or persons arising solely out of an error, omission, and/or grossly negligent act in the prosecution of the work or failure to prosecute the work and shall indemnify and hold harmless the Village, its officers, agents, and employees from all suits, claims, actions or damages of any nature whatsoever resulting therefrom. The Contractor shall assume all restitution and repair costs arising out of an error, omission and/or negligence.

The Village shall indemnify and hold harmless the Contractor and the Contractor's agents, servants, and employees against all losses, damages, taxes, liabilities, charges, costs and/or expenses which the Contractor may sustain or for which it may become liable on account of any breach or threatened breach of this Agreement by the Village.
