<p><b>I (first/last name) hereby certify that I am in compliance with all requirements under Pingree Grove Village Code pertaining to home businesses (Title 11, Chapter 6, Section 2), including but not limited to:</b></p> <p><b>A)</b> All home businesses operated in or from a residence shall comply with federal, state and county rules and regulations, village license regulations specified herein and any other applicable ordinances of the Village of Pingree Grove.</p> <p><b>B)</b> No advertising of any kind shall be permitted on the residential premises. (11-6-2 B5)</p> <p><b>C)</b> No person other than the license holder or members of the immediate family residing in the residence may be employed for a salary, commission or upon any other remunerative basis. Immediate Family: husband, wife, child, grandparent, brother, sister, or legal guardian of any of the aforementioned. (11-6-2 B1)</p> <p><b>D)</b> No condition shall be permitted which generates noise, vibration, glare, fumes, odors, or electrical interference beyond what normally occurs in a residential use. (11-6-2 B10)</p> <p><b>E)</b> No storage of materials and/or supplies shall be allowed on the grounds of the residential structure, nor shall any indoor display of materials be visible from the outside of said structure; and no home business shall occupy more than twenty-five (25%) of the living area of the structure. (11-6-2 B4, B11)</p> <p><b>F)</b> The home business shall not generate pedestrian or vehicular traffic beyond that which is reasonable to the district in which it is located. (11-6-2 B6)</p> <p><b>G)</b> The appearance of the structure shall in no way be altered for the conduct of the home business within the structure nor shall the conduct be such that the structure may be recognized as serving a non-residential use either by color, materials, construction, lighting, signs, sounds, noises, vibrations, audible or visible interference in any radio or television receiver off the premises, or cause fluctuations in the line of electric voltage off the premises.
