The Village has entered into an agreement with the US Census Bureau, to conduct a 2024 Special Census. The Village's population has experienced a significant increase since the 2020 Census reporting of 10,365. State and federal funding are generally population-based, and in the best interests of the community, the Village would like to ensure that it is receiving its proportionate share of revenues and benefits. The Special Census will be conducted through an online self-reporting response, with resident instruction mailings beginning in late March. We ask that all residents participate by responding to this important population count for our community.

At the October 2, Village Board meeting, Interim Police Chief, Chris Harris, presented Patrol Officers – Nisa Santana, Eric Huber, and Laura Freudenberger, with a 2023 Life Saving Award. The Board of Trustees joins the Pingree Grove Police Department in congratulating these officers for their swift actions and outstanding efforts in their dedication to serving the community.



Financial Highlights

For the 14th consecutive year, the Village of Pingree Grove was presented with the Government Finance Officers Association's **"Certificate of Achievement for Excellence in Financial Reporting,"** for its Annual Comprehensive Finance Report for Fiscal Year Ended April 30, 2022.

The Annual Comprehensive Financial Report (ACFR) is the Village's annual report to its taxpayers, governing board, oversight bodies, investors, and creditors. The Village's accounting firm, Lauterbach & Amen, LLP has completed its annual audit of the Village for Fiscal Year Ended April 30, 2023, reporting that the Village's net position of governmental activities increased by 5.5%, and a net position of business-type activities increased by 1.2%. Government-wide revenues totaled \$11,353,590 while expenses totaled \$9,032,504; an increase to net position of \$2,321,086. The Village's net position totaled \$83,268,741 on April 30, 2023, which includes \$63,424,084 net investment capital assets, \$2,080,983 of which are subject to external restrictions, and a \$17,763,674 unrestricted net position. The Village's General Fund reported an increase in current year of 2%, which includes an increase in total revenues of \$961,762 compared to prior year, resulting in ending fund balance of \$4,943,464.

RECENT BOARD ACTION

Pingree Grove & Ella Johnson Memorial Public Library District Inter-Governmental Agreement

At the October 2 Board meeting, the Village Board approved an intergovernmental agreement with the Ella Johnson Memorial Public Library District. The Agreement allows for the Village to donate the vacant land, situated north of the Municipal Center and south of the Community Gardens, for the potential construction of a 20,000 – 30,000 sq. ft. public library facility. Any library would be constructed and operated by the Library District.

Although the proposed library branch facility would serve as the District's primary administrative branch, it would not affect the existing library branch in Hampshire, but it would allow for the opportunity to enhance its program offerings.

For the public library proposal to proceed, a referendum will be presented to the voters for their consideration in approving the issuance of bonds to cover the costs of construction financing. The referendum would be presented during the 2024 election year.

If the Library District is unsuccessful in securing bond approval and completing the facility construction within six (6) years of the Agreement, the land would be returned to the Village.

The Village will keep the community apprised of additional information and ongoing developments.

Drinking Water & Wastewater Infrastructure Improvements

In 2022, the Board authorized the construction of a new well, drilled at Daniel Blvd. and Reinking Rd.,

to accommodate a new 1,100 gallons per minute (gpm) water treatment plant (WTP) facility. The new WTP expansion was designed to serve the expected growth of Pingree Grove over the next 20 years, by continuing to provide essential clean drinking water to the community. The cost of the WTP construction is being funded in part through a low-interest Water Supply Loan Program through the Illinois Environmental Protection Agency (IEPA), and a federal Community Project Funding grant previously awarded by Representative Underwood. As of this writing, the WTP is nearing completion with continuation of exterior site work and communications cabling, while awaiting final approval of water samples to obtain an operating permit from the IEPA. Earlier this year the Board also authorized the construction of a wastewater treatment plant (WWTP) expansion as the existing wastewater treatment infrastructure is undersized and has reached critical capacity limitations. Mass grading has begun on the site of the new WWTP located next to the existing WWTP and behind the police department. The Village received an IEPA loan from the Illinois Water Pollution Loan Program in addition to CPF funding from Congressman Raja Krishnamoorthi to help fund the project.
