

In 2023, the Pingree Grove Police Department had multiple changes in the Administrative Staff throughout the year.

Martin Racila was promoted to the rank of Sergeant in March 2023. He retired from the Hoffman Estates Police Department in 2016 after 25 years of service. Martin was sworn in as a part-time patrol officer in April 2020 and transitioned to full-time in December 2020.

Riley Jensen was promoted to the rank of Sergeant in July 2023. Riley worked for the City of Davenport, IA and the City of Crystal Lake, IL prior to being hired as a part-time officer in January 2022 and transitioned to full time in March 2022.

Christopher Harris was appointed to Chief of Police by the Village President in November 2023. Christopher started working in Pingree Grove in April 2008 as a part-time officer and transitioned to full-time in May 2012. He was promoted to Patrol Sergeant in 2015 and was then appointed Administrative Lieutenant in 2017. The Administrative Lieutenant position was reclassified to Deputy Chief of Police in May 2023 due to the job responsibilities.

Jeff Pokorney was appointed Deputy Chief of Police by Chief Harris in December 2023 to fill the vacancy of the position. Jeff started working in Pingree Grove in February 2008 as a part-time officer and then transitioned to full-time in October 2009. He was promoted to Patrol Sergeant in 2015 and is the longest member of the Pingree Grove Police Department.



Pingree Grove Police Department 5 Year Call for Service Trends



The Pingree Grove Police Department has seen a continuous increase in call volume over the past 5 years. Other than 2021 during the Coronavirus pandemic, officers have been responding to more and more calls for service. In 2023, officers responded to 1,632 more calls than the previous year. This may be due to the population increase and the rise in vehicular thru traffic throughout the community.







2023 CRIMINAL CASE REVIEW

In 2023 Pingree Grove Police Officers investigated 218 criminal complaints.

In January, officers were dispatched to a residence where a parent found a loaded handgun as well as parts of two additional guns in their 18-year-old son's bedroom. The offender was charged with multiple felonies.

In February, officers investigated a fraud where an elderly resident was tricked out of \$24,500.00 of his savings. Because of the amount of money being so significant, this case was referred to the FBI.

In March, officers investigated a report of a Criminal Sexual Assault of a 5 month old child. After a thorough investigation and forensic testing, it was determined that this alleged crime was unfounded.

In April, officers investigated another Criminal Sexual Assault where the 11 year old victim reported that he was sexually assaulted near the Community Garden. After a thorough investigation including DNA testing, this case was also unfounded.

Also in April, the Village of Pingree Grove became a victim when an unknown offender attempted to deposit two fraudulently created checks in the amount of \$32,500.00 and \$2500.00 respectively. An investigation of the origins of these two checks was conducted and it was determined that the checks originated out of state. Attempts to identify a suspect were unsuccessful. Fortunately, the Village suffered no financial loss.

June was a busy month for Pingree Grove Officers:

Officers responded to a hit and run crash that occurred in the parking lot of Minuteman Industrial. An investigation revealed that the offending vehicle left the roadway (Route 20) and struck a parked vehicle before re-entering the roadway westbound out of Pingree Grove. The driver was eventually located in DeKalb County and was subsequently charged with various offenses including Leaving the Scene of a Property Damage Crash and having a Revoked Driver's License.

Officers responded to Route 47, north of North Starks, for a Fatal Traffic Crash. An investigation conducted by Pingree Grove Officers and KCART determined that a vehicle heading north crossed into the southbound lane striking a northbound vehicle which caused another southbound vehicle to attempt to avoid the first crash and rolled over on the west side of Route 47. The driver of the northbound vehicle was killed on impact and it is believed that the crash was intentional.

2023 CRIMINAL CASE REVIEW (CONTINUED)

Officers investigated an Animal Cruelty complaint where the complainant reported that his neighbor's dog appeared injured and emaciated. An investigation revealed that the dog was severely malnourished, had no water or food and was left outside without shelter. The dog was removed by Kane County Animal Control and was subsequently euthanized due to its condition. The dog's owner was cited for Cruel Treatment of an Animal.

In July, officers investigated an elderly resident who was duped in an online romance scam. The victim ultimately lost \$68,000.00 dollars over several months. An investigation revealed that the offender was outside of the United States and because this scam involved cryptocurrency, this case was referred to the US Secret Service for investigation.

In October, Officers investigated multiple Stolen Vehicles. During the course of the investigation, it was determined that a Pingree Grove resident had their vehicle stolen. While investigating this theft, officers recovered a vehicle stolen from Bartlett and additional Burglary to Autos and Trespass to Vehicles. This case is still under investigation as officers work with other agencies.

In November, officers investigated a retail theft which led to a hit and run crash. An investigation revealed that a juvenile from Lake In The Hills stole their parents vehicle and then picked up other juveniles who ultimately ended up in Pingree Grove. One of the juveniles stole items from the BP Amoco and another juvenile (driver) who while fleeing the scene backed into another vehicle. All parties were identified and the retail theft suspect was issued a local ordinance citation and the juvenile driver was arrested and issued citations for having No Driver's License and Leaving the Scene of a Crash.

Also in November, officers investigated the second fatal crash of 2023. An investigation conducted by Pingree Grove Officers and KCART revealed that the 16 year driver was speeding eastbound on Route 72, on the wet roadway, when he lost control of his vehicle and struck a westbound vehicle head-on. The 16 year old driver was ejected from his vehicle and subsequently died from his injuries. The other driver and her passenger (brother) were severely injured and to this date are still recovering.

In December, officers investigated a report of Child Pornography received from Hampshire Police Department's School Resource Officer (SRO). An investigation revealed that a 16 year old and a 15 year old who were once dating exchanged sexual pictures and videos with one another. Further investigation determined that these photos and videos were never exchanged with anyone else. Pingree Grove Officers along with the juveniles and their parents were brought together and agreed to handle this incident amongst themselves. Both juveniles were admonished to never do this again.



VEHICLE CRASH STATISTICS

In 2023, there were 161 motor vehicle crashes reported to our police department while in 2019, only 119 crashes were reported. This is more than a 35% increase over the past five years. The National Highway Traffic Safety Administration (NHTSA) published 19,515 people died in motor vehicle traffic crashes in the first half of 2023. This is a 3.3% decrease from the 20,190 fatalities in the first half of 2022. For the first nine months of 2023, the NHTSA estimates that 30,435 people died in motor vehicle traffic crashes, which is a 4.5% decrease from the first nine months of 2022. The NHTSA also notes that vehicle miles traveled increased in the first half of 2023, by 35.1 billion, which is about 2.3 percent higher than for the same time last year.








CRASH PERCENTAGES BY DAYS OF THE WEEK




CRASH PERCENTAGES BY TIMES OF THE DAY



ARRESTS

There are those times where it is inevitable that an arrest needs to be made. When this occurs, officers are taken from other calls in order to transport prisoners, process arrestees, and in some cases, wait for a response from our State's Attorney's Officer to approve higher felony charges.

In 2023, there were a total of 101 arrests which includes traffic and criminal law offenses. Reports of arrests were down from previous years which may be attributed to the COVID-19 pandemic. The increase in arrests also is contributed by the number of full-time officers we have compared to previous years.

Over the past two years, the Police Department has increased their fleet significantly. The department had been utilizing many older vehicles with high mileage and repair costs. The addition of newer vehicles has allowed older vehicles to be taken out of the daily rotation and repurposed for court or training purposes. As new vehicles continue to be purchased, additional older vehicles will be rotated out of the fleet. This ultimately keeps the maintenance on these vehicles lower which contributes to fewer repair costs.

Recently, police vehicles have been manufactured by Dodge. This is a new change as previous vehicles were made by Ford. At the time of purchase, the Dodge vehicles were more readily available, so the decision was made to switch vehicle manufacturers. A fleet of similar vehicles is always best so the police department will continue to purchase Dodge vehicles for future fleet needs. A Dodge Ram pickup truck was recently purchased for a dual purpose. This Ram not only acts as a patrol vehicle but is also used by our civilian community service officer for transportation of large items such as bicycles, car parts, and other items that are too large to fit in a standard patrol vehicle.





RECORDS REQUEST

Not only are our police officers busy with call volume, investigations, and arrests, our Records Staff is continuously busy with data entry, gathering information for officers when needed and handling requests from the courts regarding upcoming cases. This does not consider the incoming Freedom of Information Act (FOIA) requests, requests from the Department of Children and Family Services, Background requests, additional requests from the State's Attorney's Office and other requests received throughout the year.

A FOIA request can be submitted to an agency to request copies of agency records. This has become more well known as a way to gather information on reports in our community. We have seen a dramatic increase in FOIA requests in the past few years. These reports take time as personal information such as dates of birth, phone numbers, social security numbers, and other sensitive information that needs to be redacted. Also, any juvenile information including names, addresses and statements need to be removed from any report unless a specific exemption has been noted. These can take anywhere from an hour to days to find and gather this information, redact the sensitive information, and then have a second person verify that all of the sensitive information was found and removed.



BODY WORN CAMERAS AND IN CAR CAMERAS

In January of 2023, the department successfully implemented Body Worn Cameras for all sworn officers. These cameras are worn daily by all officers when responding to calls or having citizen contact which could potentially lead to an investigation. Each week, footage from each camera is reviewed by supervisors and is submitted to the Illinois Law Enforcement Training Standards Board. The cameras have not only increased transparency and public trust but have been a valuable tool in providing enhanced evidence in both traffic and criminal prosecutions. By implementing body worn cameras in 2023, the department is several years ahead of the state-mandated implementation deadline of 2025.

New In Car Cameras were made operational in 2023 and are synced with the body worn cameras. These cameras are installed inside each of the patrol vehicles. They record traffic stops and officer interactions. The footage from the in car cameras is reviewed weekly along with the footage from the body worn cameras.

POLICE DEPARTMENT TRAINING

Providing frequent and effective training remains a top priority of the Pingree Grove Police Department. Continued training is essential for providing officers with the tools necessary to successfully navigate an everchanging career field. Additionally, state-mandated training requirements continue to expand as legislators emphasize the importance of continued law enforcement training. The department is pleased to report that in 2023, the department closed out the year in 100% compliance with all state-mandated training.

In 2023, officers received over 2,500 hours of in-service training which included Law Review, Range Training, Less Lethal Training, Hazardous and Bloodborne Pathogen Training, CPR, AED and First Aid, and other various applicable specialties.

Some of the specialized training attended by officers included Supervision for Police Personnel, Investigative Skills, Crime Investigation, Tactical Pistol/Rifle Training, Firearms Training Course, Police Report Writing, Leadership Courses, Defensive Driving, Taser Instructor, and numerous other law enforcement related fields.

EVERBRIDGE NOTIFICATION SYSTEM

The Everbridge mass notification system was implemented in the Village of Pingree Grove in 2023. This system allows village and police administration staff to provide critical information directly to community residents as emergencies happen. The alerts provide information on where to go, what to do and how to stay informed through text message, email, cell phone, home phone or work phone. Residents have been encouraged to sign up for the Everbridge notifications as this is an important way to stay informed and connected in the Village of Pingree Grove especially in emergency situations.

PRESCRIPTION MEDICATION DROP OFF

The Pingree Grove Police Department recognizes the societal abuse of prescription medications and the need for residents to dispose of those medications in a safe and proper manner. They also recognize that the improper disposal of medications is harmful to the environment.

Expired and unwanted prescription medications can be turned into the Pingree Grove Police Department by anyone- resident or nonresident- and placed into the Prescription Drug Return Collection Box which is located in the lobby area.

The Police Department will accept prescription medication in the original container or loose prescription medications. Over the counter medications and vitamins are not accepted.

The Police Department will not accept needles, sharps, thermometers, bloody or infectious waste, medications from businesses or clinics, hydrogen peroxide, aerosol cans or inhalers, ointments, lotions or liquid medications.

We encourage everyone to stop by and drop off what they have so it can be disposed of correctly.
