



DISPUTE CITATION

ADMINISTRATIVE ADJUDICATION HEARING WRITTEN EVIDENCE SUBMISSION FORM

Those who have been served with a ***Village of Pingree Grove Ordinance Violation Notice*** for vehicular standing, or parking, or an ordinance violation(s), may contest the alleged violation(s) on its merits:

1. **In Person** – attend an Administrative Adjudication Hearing on the date and time indicated on the citation(s); or,
2. **In Writing** – to contest the citation in writing and without having to appear in-person at the scheduled Adjudication Hearing, complete this *Written Evidence Submission Form* and submit to the Pingree Grove Police Department. Written disputes must be received prior to the hearing date. Citations that indicate a ***“MUST APPEAR”*** are ineligible for written disputes.

If you choose to contest the violation(s) in writing, complete this ***Written Evidence Submission Form*** in its entirety, include any documentation or photos that you would like to have considered to support your defense, and return in person, by mail or email to:

The Adjudication Hearing Officer will review and adjudicate your written request at the scheduled Administrative Adjudication Hearing date that appears directly on your issued violation notice.

By contesting your violation, you are subject to Village Code 1-11-9-F which states, “If a Defendant is determined to be liable in a judgment issued by a Hearing Officer, such Defendant shall pay to the Village an administrative hearing fee of up to fifty dollars (\$50.00), in addition to any other amounts owed to the Village as penalties for ordinance violations.”
